### **General Description:**

The Centre for Family Medicine (CFFM) Family Health Team is a well-established family health team providing primary health care and related services to residents in the Kitchener-Waterloo region. The CFFM has successfully delivered both clinical and eHealth related projects and has established the eHealth Centre of Excellence (eCE) to manage and coordinate local eHealth programs and research activities.

As the WWLHIN Change Management and Adoption Delivery Partner for the cSWO Program, eCE works with health care providers across the continuum of care to improve the use of information in the delivery of healthcare. Drawing from a network of clinicians, change management specialists, technical experts, researchers, project management, and healthcare strategy and alignment expertise, the eCE works with organizations to achieve goals related to the deployment, adoption and appropriate use of electronic health tools

The Health Data Analyst and Evaluation Specialist will work to support the various research and evaluation projects being completed by the eCE Benefits Realization team. The Health Data Analyst and Evaluation Specialist will perform a key role in data compilation and manipulation, and use multiple tools to present both quantitative and qualitative data for analysis and evaluation. Successful candidates will have strong analytic and presentation skills.

- Work with the Benefits Realization team to support the data needs of their projects
- Design and maintain databases, data collection forms, error checking methods and related programs for efficient collection, analysis, and reporting
- Apply predictive modeling techniques to identify target populations
- Help produce data reports and respond to questions from team members and external stakeholders
- Help present reports and materials as required
- Other duties as assigned

- Masters' degrees in Health or Management sciences, or relevant field of study required
- 1-2 years of experience in a health data analyst role
- Working knowledge of statistical analysis methods and applications
